NOTES:-

1. The units registered under Single Point Registration Scheme of NSIC are eligible to get the benefits under "Public Procurement Policy for Micro & Small Enterprises (MSEs) Order, 2012" as notified by the Government of India, Ministry of Micro Small and Medium Enterprises, New Delhi vide Gazette Notification dated 26.03.2012. 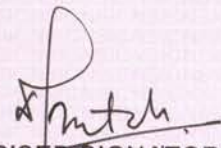
